- 9) 30-Year Service Award for Quinn Johnze, Operations Superintendent. General Manager Sanders provided a recap of Quinn's career and highlights of the past 30 years of service to the district. The Board extended their appreciation and thanked Quinn for his service to the District.

 - a. Well 8 Rehabilitation. Pump is set and has been in service for over a 1 week..
 - b. Valle Vista PRV Installation: District crews have completed the installation of a 6" PRV on Valle Vista that can serve the lower Eucalyptus Hills area to Riverside Dr.
 - c. District crews are starting to organize the yard in preparation of the 100 year anniversary event in August. Includes painting the piping in the treatment plant.
 - d. District crews have completed the 2024 inventory count for the annual audit.
 - e. Toyon Hills PL RPL. Asphalt work has been completed. Project 100% complete.
 - f. AWP Pipeline Installation. Contractor has slowed down on Mapleview. Next area is Channel Rd. Bridge area, and is currently under construction. District crews are working valves to prepare for pipeline crossings.
 1 Mainbreak, 1 Service Leak, 0 Fire Hydrants

- 16) CWA Report. Director Hilliker reported that the Admin and Finance Committee conducted a rate hearing and a public hearing. The City of San Diego pushed to keep the increase to 14% and during extended discussion, the board decided to increase the rates 7.2% to cover the MWD increase and the Rainbow and Fallbrook roll off increase. The Board will hold a second public hearing during the July meeting to discuss the rates again. WA staff is making a strong case to keep the rate increase at the 15.4% or 18% level to insure that the bond rating doesn't get downgraded leading to the interest rates available to the WA to go up.
- 17) Director's Report and Ad Hoc Sub-Committees Reports. No reports.
- 18) Manager's Quarterly Report. The General Manager reported.
 - Legislation Update: Two bills are being opposed by most agencies including ACWA. AB 2735 and SB 1255.
 - UCMR 5 Sampling Update: Testing of the unregulated chemicals required by the EPA has been completed. The EPA will evaluate the results to potentially make some chemicals required for monitoring and testing.

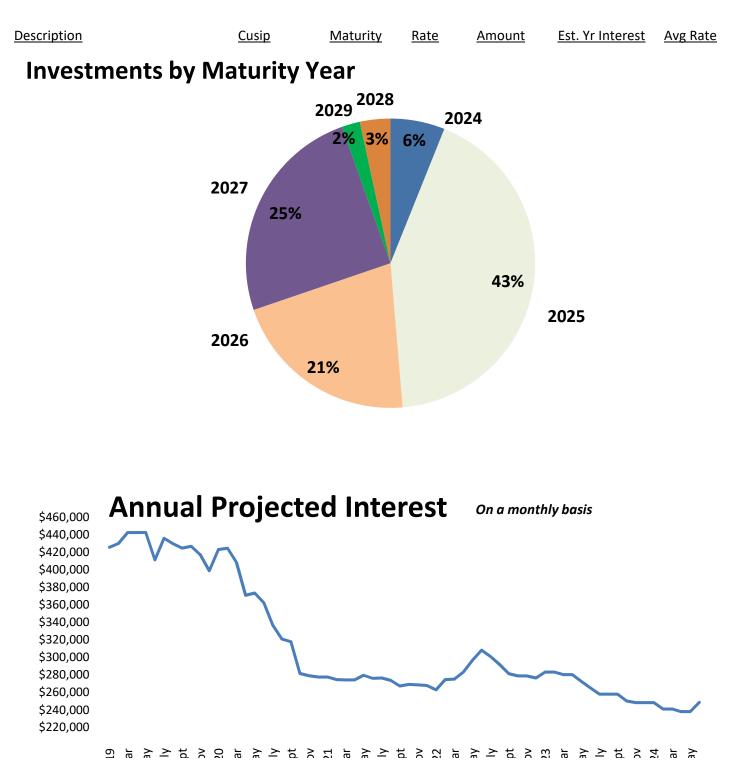

New Revenues, Budget Cuts Trim Wholesale Rate Increase for 2025 Increase up to 14% approved for 2025 after more cost cutting

July 25, 2024 – Federal grant funds, an innovative water transfer, and operating budget cuts helped minimize wholesale water rate increases for 2025 despite long-lasting inflationary forces and climate impacts that are pushing prices higher.

The San Diego County Water Authority's Board of Directors today approved a total increase of 14% in wholesale water rates for next year, while directing a one-year delay on a \$7 million capital project and \$2 million in additional cuts to the agency's operating budget. That rate combines the Board-approved increase in June that covered rising prices from the Metropolitan Water District of Southern California with an additional increase to pay for other water supplies, along with financial and infrastructure needs.

During a months-long public process that included two public hearings, the Water Authority cut initial rate increase projections in half. That work included a decision by the Board to apply approximately \$19.4 million in new federal grant money to lower 2025 rates. In addition, a new pilot program allows retail water agencies to trim about 1.5 percentage points from next year's bill by prepaying fixed costs. For participating agencies, this will reduce the 2025 effective rate increase from 14% to 12.5%.

Every customer will feel the impact differently, based on their water use and how local retail water agencies handle costs.

"We realize cost increases are hard to swallow, and we are doing everything possible to combat rate inflation now and in the future. Our efforts include cutting expenses, deferring projects and purchases, selling surplus water, and seeking additional grant funds to boost income."

The 2025 rates are driven by passthrough costs that increase Water Authority rates 11% before accounting for internal factors. Passthroughs include the cost of water from all sources: Metropolitan, the Claude "Bud" Lewis Carlsbad Desalination Plant, and conserved water from the Colorado River. In addition, prices are driven by higher costs for inputs and the impacts of two

member agencies detaching from the Water Authority. The detachment of the Fallbrook and Rainbow districts means millions of dollars in costs must be spread to other water districts in the Water Authority's service area.

Internal factors account for a 3% increase in wholesale water rates, needed to meet debt obligations bound by legal covenants and adequately maintain the 308-mile system of critical pipes, pumps and facilities delivering reliable water to more than 3 million San Diegans.

To mitigate rate increases, the Water Authority had previously cut 2% from its fiscal years 2024 and 2025 operating departments budget previously approved by the Board – a figure that will increase by \$2 million in response to today's Board direction. The operating departments include all staff and account for just 7% of the agency's overall budget. More than 90% of the budget is for debt, water purchases and treatment, and infrastructure maintenance.

In December, the Water Authority saved \$20 million with an innovative water transfer with the Metropolitan Water District of Southern California and the Imperial Irrigation District, contributing to a 3% reduction in 2025 rates. The Water Authority continues to pursue similar, new strategies to alleviate costs to ratepayers in the future.

From 2019 to 2023 the Water Authority spent \$201 million in reserves, including more than \$90 million in settlement dollars, to provide ratepayer relief during the COVID-19 pandemic, stubbornly high unemployment, and skyrocketing inflation. With the use of additional reserves in 2025, the Water Authority's Rate Stabilization Fund is anticipated to fall nearly \$30 million below Board policy.

For the past decade, San Diego County has been protected from drought-induced water cutbacks due to approximately \$3 billion in long-term investments in water security. That strategy emerged in the early 1990s following an economically devastating drought. In addition, the region dramatically cut water demand, reducing per capita water use by more than 50% since 1990.

As a public water agency, the Water Authority doesn't have stockholders or profits; it is required by law to set rates at the cost of service. Detailed information about rates, including a third-party cost-of-service analysis, starts on page 5 of the July Board memo.

Michael Smolens: San Diego faces minimal water cutbacks under state conservation plan

Expensive, long-term investments in recycling, conservation, storage, desalination and imported supplies put the region ahead of the conservation curve

San Diego County's water world hasn't had much good news lately, with looming budget problems and whopping rate increases.

Well, here's some: The state's new mandatory water conservation plan won't require big reductions locally.

That's due mostly to decades of spending on recycling, desalination, storage, conservation and imported supplies.

Just four of the San Diego County Water Authority's 23 member agencies face any cutbacks at all — and they have many years to reach their goals.

The San Dieguito Water District faces the largest reduction of 6.9 percent. That's followed by the Olivenhain Municipal Water District (6.4 percent), Carlsbad Municipal Water District (6 percent) and the Santa Fe Irrigation District (3.6 percent).

There will be additional costs likely for all agencies because the sweeping plan includes detailed reporting and data-collection requirements. That may be more of a burden for smaller agencies than larger ones with more bureaucracy already in place, such as the city of San Diego.

Big or small, any new costs won't be welcome among the SDCWA umbrella group, which already is expected to consider <u>raising rates</u> on members by around 15 percent later this month. Most, if not all, of those increases may be passed on to individual customers.

The authority is facing a substantial budget shortfall resulting in large part from the investments that now apparently have spared its members from more harsh impacts of the new conservation plan that will be felt elsewhere in the state.

The problem, ironically, is partially the result of local customers significantly reducing water consumption for decades. That wasn't anticipated by the water authority, which is now awash in water that it figured on selling to member agencies to help pay off the costly investments. SDCWA is seeking to find markets to unload some of its supplies and recoup some revenue.

That situation isn't going away, but at least it won't be compounded by having to make significant cuts in water use.

"It's no surprise so many of our member agencies are already in compliance with this new plan," Dan Denham, water authority general manager, said in a statement.

"It shows how our strategic investments in developing our local water supplies continue to provide water security and benefit our region."

Under the plan <u>approved</u> unanimously by the five-member State Water Resources Control Board on July 3, some agencies in California will be required to cut water usage by more than 30 percent. That's a lot, but a renegotiated timeline means that the goal might not have to be reached for 16 years, which, in theory, suggests cuts could come at about 2 percent a year.

But the plan sets goals tailored to each agency. For instance, the Los Angeles Department of Water and Power also has made significant gains in conservation and would not need to achieve its first reduction of 6 percent until 2035, according to the Los Angeles Times. Other areas, such as the city of Bakersfield, would need to cut back 25 percent by 2030 to stay in compliance.

The plan is a significant departure from past mandatory, once-size-fits-all cuts during droughts. This system is more flexible, taking into account past investments, conservation practices, demographics and regional variations, such as treating hotter inland areas differently than milder coastal regions.

The cuts apply to urban water agencies and not agricultural districts, some of which also are embarking on separate <u>conservation plans</u>. The plan approved this month applies to the water utilities and not households, but the reductions may be felt by individual customers.

While most SDWCA members and many other agencies across the state essentially can stand pat through 2040, that didn't appear to be the case initially. The original plan called for deeper, faster reductions.

A report by the nonpartisan Legislative Analyst's Office in January <u>criticized</u> that plan as costly, unrealistic and "unnecessarily complex." Water agencies rebelled and after subsequent negotiations, the cuts and timelines were <u>relaxed</u>.

Not everyone was happy with the outcome.

"The State Water Resources Control Board has decided to kick the can of California's water future down the road at a time when we can least afford such inaction," Assemblymember Laura Friedman, D-Burbank, <u>told</u> CalMatters after the board vote, adding that California must invest more in water efficiency or be forced to spend billions on wastewater recycling and desalination.

Friedman authored one of the bills that required the mandatory conservation rules.

More than a third of suppliers serving about 42 percent of the state's population will not need to change their water use to meet the standards under the new plan — up from 18 percent under the previous version, <u>according</u> to state data cited by CalMatters.

The Pacific Institute was among environmental organizations that expressed disappointment in the conservation rollbacks, but supported the approach.

"I do think it's a good framework," Heather Cooley, director of research at the Pacific Institute, told the Times. "But I continue to think that we have far more opportunity across the state to reduce water use and to help prepare our communities for more extremes — more extreme droughts, hotter temperatures, all of the things that we're already seeing and that are going to get worse."

Much of the state plan is driven by concerns over global warming leading to increased water scarcity — despite interspersing wet years. That, along with overuse, has depleted the Colorado River, which provides water for some 40 million people in seven states and Mexico.

That's where San Diego gets much of its water. River stakeholders and the federal government already have acted to take less water from the Colorado, though a broader pact to divvy up the river is expected in a couple of years.

That may do more to shape San Diego's water outlook than the new state conservation plan.
